


#### **ADMINISTRATION**


## **COMMUNITY & ECONOMIC DEVELOPMENT**

- Burke ESFR Program: 4 under construction, 1 out to bid and 5 to inspect


- Rhodhiss CDBG Rehab Program: 2 under construction, 2 out to bid, 3 inspected and 3 to be inspected




