Urgent Repair (URP) & DEQ-ARPA

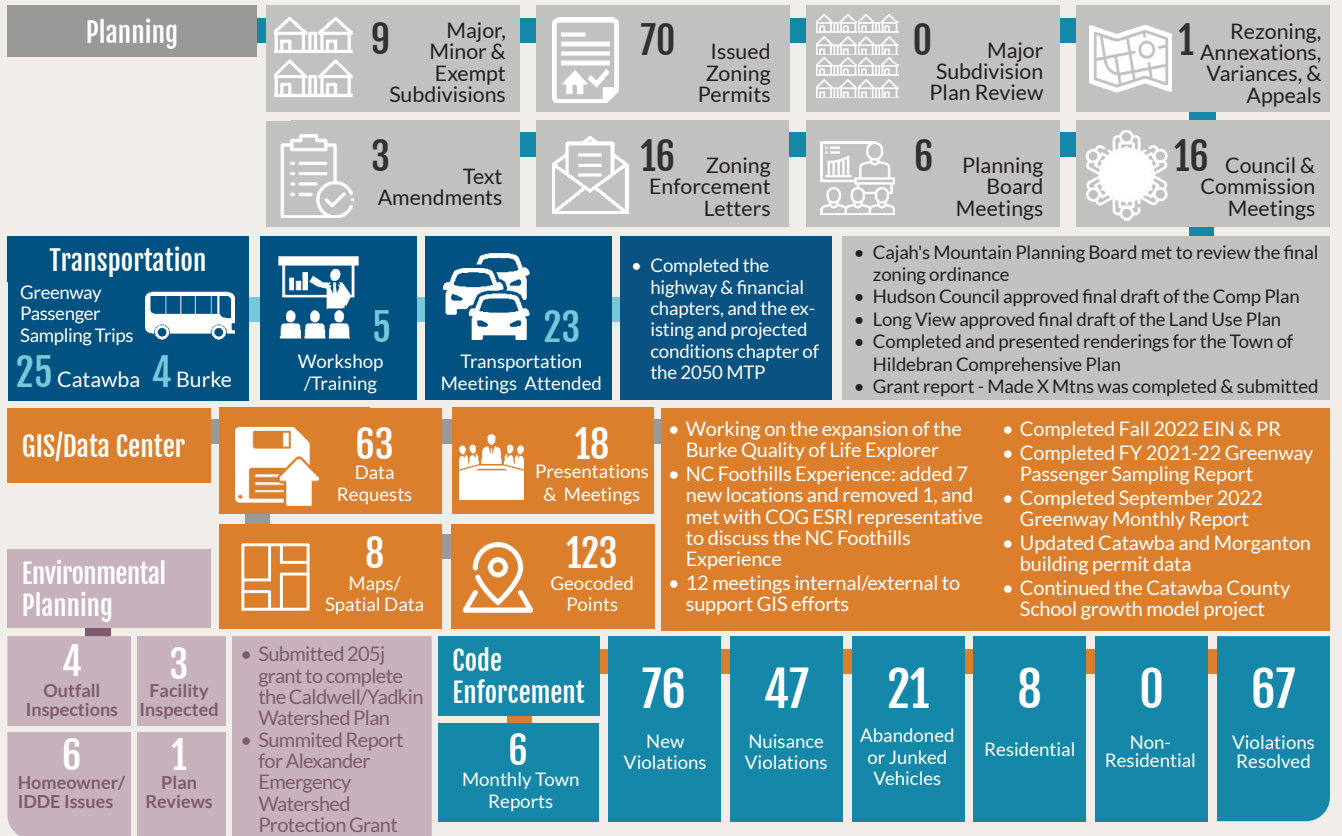
- 8 Urgent Repair funds houses under contract in Alexander/Catawba Counties

- Conover has 6 - CDBG SSH houses under contract, and 2 houses out to bid

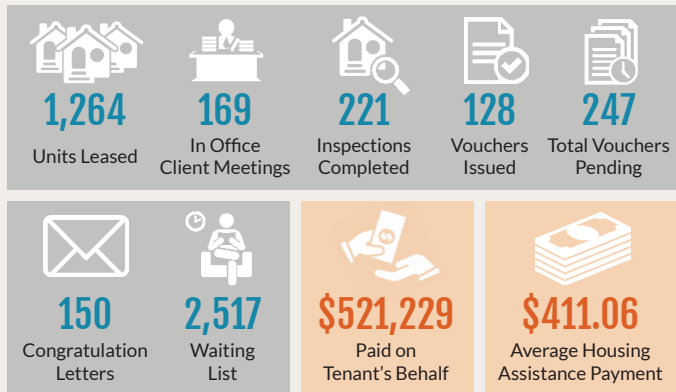

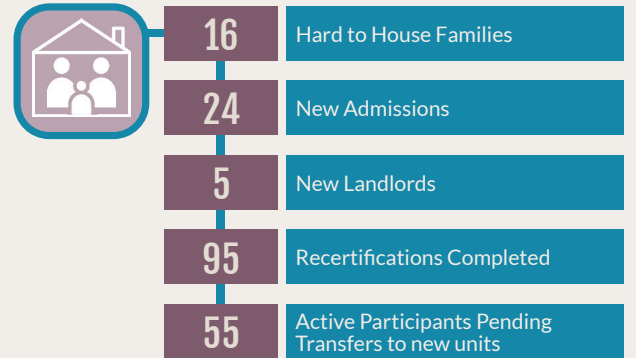
