Other Programs/Projects

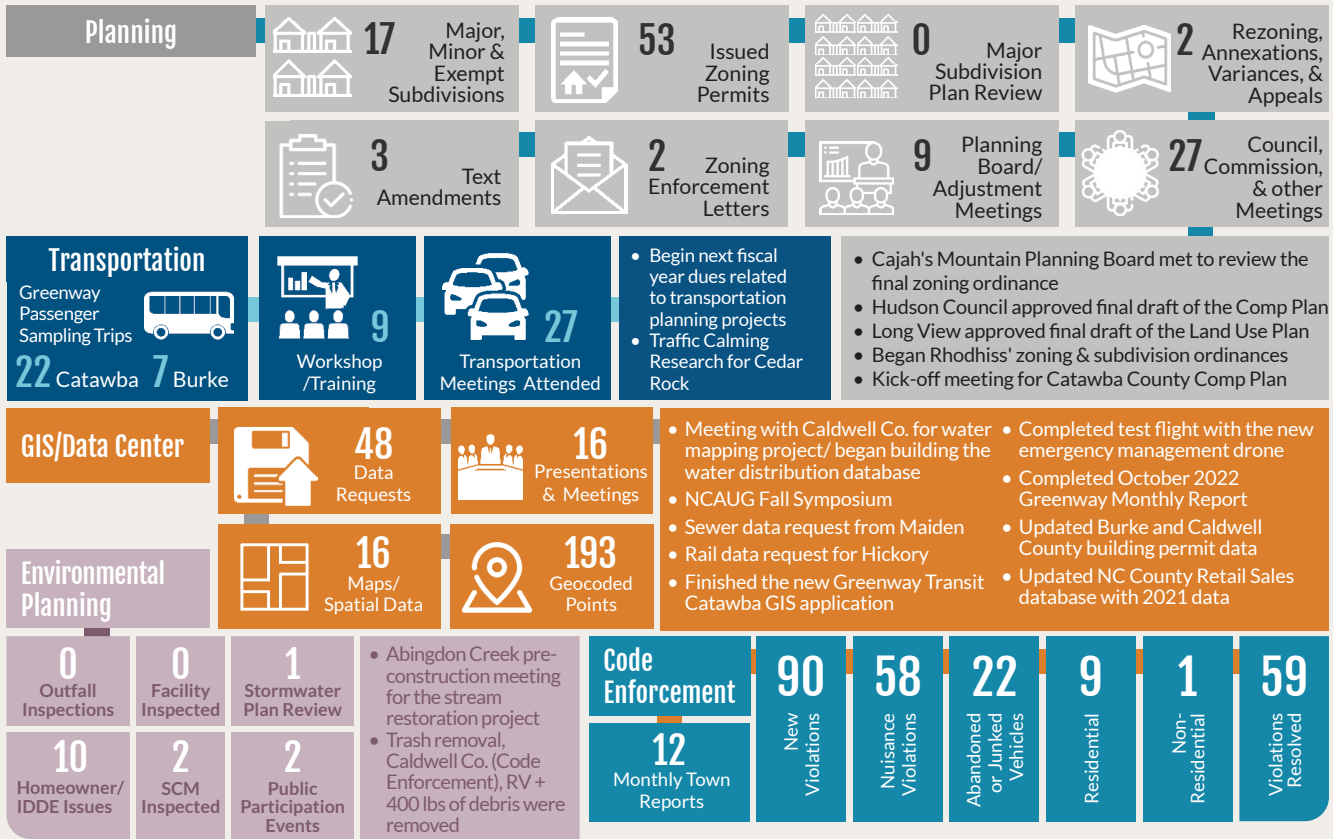
- Conover CDBG SSH houses under contract-5

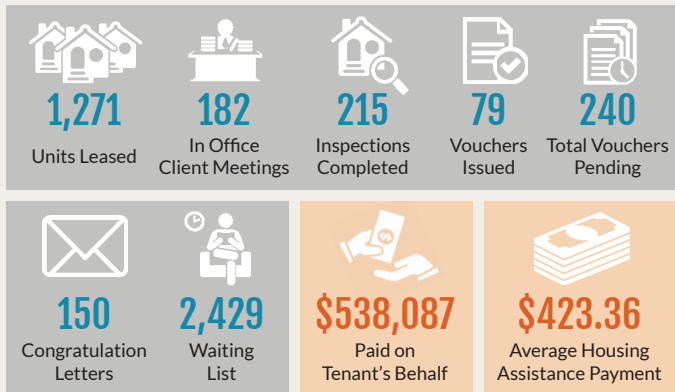

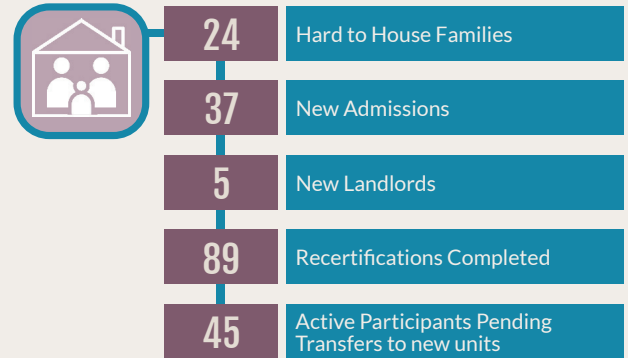
